One of which must be a colloquium (HIEA 162-170).</i></li> <li>• <i>A combination of courses from 3 different departments that offer Chinese Studies topics (Example: HIEA, LTEA &amp; CHIN)</i></li> </ul>	<ul style="list-style-type: none"> <li>• <i>Program Director and Academic Advisor oversee requirements, which are endorsed by full faculty.</i></li> <li>• <i>Program Director, individual professors and Academic Advisor act on all requests/petitions for variation of requirements.</i></li> <li>• <i>CEP Review Committee</i></li> </ul>	<ul style="list-style-type: none"> <li>• <i>Internally the program adjusts requirements and course sequences for the major.</i></li> <li>• <i>Individual course instructors use feedback to modify their classes.</i></li> </ul>
