April, 2013</p>	<p><i>The Warren College Writing Program (WCWP) has a two-course sequence, WCWP 10A and 10B, as well as an upper division course, WCWP 100. The purpose of the courses is to enable undergraduate students, through intensive practice, to read and write academic arguments in preparation for their work in various academic disciplines. Classes operate as workshops and center on discussion of academic arguments and student work. Students are introduced to a model of argumentation based on claims, premises, and evidence).
